<u>Ufford Park Golf Club</u> <u>Membership Rules and Regulations</u>

as at 1st April 2008

Name of Club & General Conditions

The name of the club shall be the Ufford Park Golf Club.

The property of the Club is vested in Ufford Park Ltd ("the Company") The Directors of the Company shall have the complete management and control of the Club and its Staff. The Directors shall form Committees and constitutions, shall fix entrance fees, rates of subscription, number and conditions of Membership and the scale of the charges and shall have power to alter such Rules and Conditions and to make such new Rules, Regulations, Conditions and By-Laws as they may from time to time consider it desirable. Membership will be for a minimum of 12 months.

Categories of Membership

<u>Seven-Day Membership</u> – Unlimited Play when course is open and tee times are available.

<u>Five Day Membership</u> (Inclusive of Bank Holidays) -Unlimited play Monday to Friday when Course is open and times are available

<u>Intermediate Membership</u> – As per 7 Day Membership but limited to those aged between 19 and 25 years old as at 1st January each year.

<u>Junior Members</u> will be admitted to the club after an assessment by the representative of the company. <u>Associate Membership</u> –As per 7 Day Membership but must pay a Green Fee equivalent to the Members Guest Rate for the day but cannot sign in visitors at the guest rate. Associate Members are eligible to enter Club Competitions.

<u>Second ("Away") Club Membership</u> – Unlimited play Monday to Friday when Course is open and times are available. You MUST be a full playing Member and remain a Member of your "Home" Club at all times.

Payment of Subscriptions

The Annual Subscription becomes due in full on or before the 1st January each year.

Payment may be made by monthly Direct Debit but will be subject to a surcharge and in the event of non payment the outstanding balance will immediately become due in full.

A levy is to be paid annually, on or by 1st January to the Golf Club, by all adult Members of the Golf Club. The amount of this levy is determined each year at the Club A.G.M.

Course usage

Standard play on the golf course is from Red & Yellow tees. White tees may be used for practice prior to any club/inter club competition but only after seeking permission from Golf Reception Staff

Members

All membership enquiries and requests are to be made through the Club Secretary/Manager. Members are not eligible to play in Club competition/events if their subscription is in arrears. N.B. This does not apply to those with current Direct Debit mandates.

Tees will be reserved for all official club events with prior liaison with the Club Secretary/Manager All Members will register with the Golf Reception/Course Marshal 10 minutes before their teeing off time and all green fees for guests and visitors must be paid prior to play.

All membership Function requests to be made through the Club Secretary/Manager.

Notices, which are displayed near the Golf Reception must be read and adhered to. Members agree to adhere to Ufford Park Play and Dress Code.

Any Member with a grievance against the course or Club may request a grievance form from the Golf Reception and return it for the Club Secretary/Manager's attention who will engage the appropriate action In no instance may a servant or employee of Ufford Park be reprimanded by a Member. The Company and the management of Ufford Park reserve the right to amend these Rules and Regulations. A current copy shall be posted on a notice board at the premises.
